#### 6. Cancellation & Refunds

If a client wishes to cancel a service <u>before the commencement of writing</u>, a refund will be given less **\$60** cancellation fee. No cancellation fee will be paid after **20 business days**.

<u>A refund will not be given once writing has commenced</u>. Writing commences on the return of the questionnaire or completion of the phone call.
